Bemerkungen:

Von Eurodoc ist die Aufforderung zur Zahlung des Mitgliederbeitrags 2014 erst im Januar 2015 eingetroffen.

Die Zahlungen des Mitgliederbeitrags von CSWM, MUL und ACIDE für 2013 und 2014 sind noch ausständig.

Mitgliedsbeiträge für 2015 noch nicht in Rechnung gestellt, Projektkonto endlich auflösen.

7 Admittance of new full members

Association des assistantes et des assistants de la HEP Vaud ADA, University of Teacher Education Vaud, applies for membership with actionuni.

Unfortunately, no member of ADA could attend the assembly of delegates. Discussion:

- The applying association should be presented at the assembly. They should apply again next year.
- It is important to give positive and welcoming signals to potential members. HEP Vaud represents University of Teacher Education – it is still essential to win new members of this university type.

The delegates accept ADA as new member of actionuni with 12 abstentions.

8 Change of Statutes

Due to unions of associations from different University-types and according to the definition of the member fee (see point of agenda 9), some passages of the statutes need to be re-written. The board suggests defining the number of votes per association per number of members, not per number of *paying* members, to create a balance between organisations with and without membership fee (Art. 17, Abs. 1). Instead, the board suggests creating a new paragraph which allows applying for a reduction of the member fee to the board of actionuni (Art. 32, paragraph. 3).

Below the passages and suggestions by the board (modifications/additions in bold):

§ 4 ² Die ordentlichen Mitglieder werden gehören mindestens einem der folgenden Typen an zugeordnet:

§ 17 ¹ Die Anzahl Delegiertenstimmen pro ordentlichem Mitglied wird nach Anzahl seiner **zahlenden** Mitglieder bemessen.

§ 22 Der Vorstand setzt sich aus maximal sechs Personen zusammen, wobei: [...] b) jeweils maximal zwei Personen **den** universitären Hochschulen (kantonalen Universitäten und Eidgenössische Technische Hochschulen), **den** Fachhochschulen und **den** pädagogischen Hochschulen **angehören müssen vertreten**.

§ 32 ² Der jährliche Mitgliederbeitrag der ordentlichen und der assoziierten Mitglieder richtet sich nach der Anzahl deren **zahlende** Mitglieder.

³ Die Reduktion oder der Erlass des Beitrages ist möglich. Hierzu ist ein begründeter Antrag an den Vorstand zu stellen.

Discussion

Article 22 has to be completed according to the decision of the delegates at the last assembly (07.11.14): If a vacancy in the board cannot be filled with a candidate of the according university-type, the delegates of this university-type can decide to leave the seat temporarily to a candidate of one of the other university-types. > The board will complete the wording of this passage.

Reduction-paragraph

- Why application to the board and not to the assembly? > practical reasons, board has executive functions
- Are there criteria for a decision on an application? > no, there are none

Cancelling of the "paying members"

- Pro: trust, no forcing of the member associations to change their structures
- Contra: non-paying organisations benefit at the expense of the paying organisations

Vote "paying vs. non-paying members"

Three options come to vote

- a) Article 17 without "paying members"; Article 32 without "paying members"
- b) Article 17 without "paying members"; Article 32 with "paying members"
- c) Article 17 with "paying members"; Article 32 with "paying members"

First round: all options

The delegates decide to change the articles as follows:

§ 17 ¹ Die Anzahl Delegiertenstimmen pro ordentlichem Mitglied wird nach Anzahl seiner **zahlenden** Mitglieder bemessen.

§ 32 ² Der jährliche Mitgliederbeitrag der ordentlichen und der assoziierten Mitglieder richtet sich nach der Anzahl deren **zahlender** Mitglieder.

The delegates decide unanimously to complete article 32 with the additive paragraph on the option to file an application to the board for reduction of the member fee.

9 Definition of the member fee

The board suggests a fee regarding the number of members of the associations (see supplement). The working group "finances" proposes an option which considers critical sizes of associations (i.e. 100 instead of 99 members) and includes a minimum and maximum fee.

The following decisions have to be made by the assembly:

- a) Fixed fee per member (i.e. 1CHF) vs. decreasing fee per member (i.e. 0.8CHF above than 50 members): should there be a fixed fee per member?
- b) Minimum fee per member association: should there be a minimum fee per member association?
- c) Maximum fee per member association: should there be a maximum fee per member association?

The assembly of delegates decides to install:

- a) no fixed fee per member
- b) no minimum fee per member association
- c) a maximum fee per member association

The assembly of delegates defines the maximum member fee to be CHF 600.-The assembly decides furthermore the starting point for calculations to be CHF 1. - per member of the associations (40 votes, 7 abstentions).
