1 Welcome and information

7 Financial Report 2017/18 and discharge of the board (slide 16)

The financial report was sent via email beforehand.

Audrey Loetscher presents the financial report, as the treasurer Armin Zenker could not attend the meeting. The finances are just enough to cover the basic expenses.

Antoine Chollet (Uni Lausanne) suggests doing a more professional accounting (e.g. balancesheet, budget).

The auditors, Carla Duss (PH Luzern) and Martin Roszkowski (ETHZ) have verified and released the accounting. They agree that it could be organized better and could give some input to the cashier.

The board asks the delegates to approve and to discharge the board.

The assembly of delegates approves of the account (Yes: 44 / No: 0 / Abstentions 0) and the board is discharged (Yes: 43, No: 0, Abstentions: 1).

The board thanks the auditors, Carla and Martin, and the treasurer, Armin, for their work.

8 Membership fee 2018 (slides 17&18)

The board suggests using the same calculation method for the 2018 membership fee as for the last three years: tanh with maximum rate ($a_0 = 1.00$ CHF). Maximum fee per member association of CHF 600.-, starting point for calculations at CHF 1.-.

Members who did not already give their information about number of members (total; defines number of delegates with actionuni) and number of members paying membership fee with their organization ("paying members"; defines member ship fee with actionuni) are asked to do this soon (president@actionuni.ch).

The assembly of delegates approves unanimously of the calculation method and the membership fee for 2018.

c) Vote on Quota-Question "À titre de moyen temporaire, l'instauration de <u>quota</u> doit être soutenue"
 Yes : 27
 No : clear minority

d) Vote on the paragraph "Die aktuelle Personalstruktur der Universitäten leidet unter dem fast vollständig fehlenden mittleren Management. Dies macht nicht nur den Einstieg in eine akademische Laufbahn unattraktiv, sondern führt auch zu einer funktionalen Überlastung der Lehrstühle."
